1. Grant of License. Author expressly acknowledges and agrees that PDA is under no obligation to publish, market, advertise or distribute the Content or the Works on the Blog or elsewhere or to promote Author in any respect, other than to attribute the Content to the Author if, where and when published or distributed, at PDA’s sole and exclusive discretion.
